
On Monday Cathy Miller told The Californian why she has a policy against making wedding cakes for same-sex couples.

Such a refusal might have been possible, even common, 70 years ago, but most people today would agree that it's now unacceptable. So why is it OK to discriminate in precisely the same way against the gay community? State law, federal law and basic fairness demand that people who choose to run a commercial business must provide service to any customer who comes through the door, irrespective of their nationality, color, sex or orientation.

Miller needs to acquaint herself with these facts. And, whether they with agree it or not, everyone does. It's the law, and it's founded on a sound American principle: That all men (and women) are created equal, with certain inalienable rights. Being able to enjoy a wedding cake, though not specifically etched in law, is

Same-sex couple got Tastries wedding cake, learned later that owner refuses cakes for others

Elena and Marissa Delgado walked into Tastries bakery two weeks before their July 1 wedding holding hands, they said.

They were nervous. Another cake order had fallen through and they were worried about getting someone to make them a cake on such short notice.

But, both women said, the experience at Tastries was perfect.

Employees of the bakery took their order for a fanta tic four-tier, white-and-gold wedding cake, took their deposit and sent the two women on their way talking about the exceptional service at the Rosedale Highway bakery

On the day of the wedding, Elena said, the cake arrived and a Tastries employee put the cake topper two women in dresses on top of the cake.

Everything was perfect. "I would never bash their cake. The cake was delicious. The service was amazing,' Elena Delgado said.

Which is why Elena and Marissa Delgado were stunned over the weekend to learn that Tastries owner Cathy Miller had refused to make cakes for two samesex couples in the past week.

'It's terrible for anyone to be discriminated against. Elena said. "We feel very hurt by that and we feel for

them." Miller's daughter, Katie Miller, said Tastries looked into the contract with the Delgados and there was no evidence that the two women were intending to marry each other.

The staff member who took the order, Katie said, did not remember the pair holding hands or indicating in any way they were ordering a cake for a same-sex marriage.

A copy of the order form provided to The Californian

shows the cake was ordered by Elena Davis to be delivered to First Congrega tional Church on Stockdale Highway.

Information about the type of event that the cake was for was not filled out.

Notes on the form indicate that the cake topper and flowers would be at the event location.

On Monday Cathy Miller explained her motivations to The Californian after two same-sex couples commented on Facebook that she had refused to make wedding cakes for them.

"As Christians we have a love for everyone. We want to embrace everyone. We are all God's children. We are happy to make birthday cakes and cupcakes and cookies and brownies for everyone. We want to celebrate each individual regardless, she said.

But, she said, she has to follow her beliefs.

"My conscience doesn't allow me to participate in certain activities that are contrary to my Biblical be-liefs," Miller said. "I pray that we can all come to an understanding so that we can continue to get along."

They have jobs in oil sales and finance.

"We attend church ourselves on a regular basis, Marissa said. "We're just typical residents of Kern County."

Marissa Delgado said that if Miller is opposed to serv-ing gay people, she should make it clear to customers so they could take their business elsewhere.

'I wish somehow she would post her policy so people could know right away," she said.

They can only speculate about why they were able to get a cake when others were turned away.

'We did not talk to the owner ourselves," Elena Delgado said. "That probably made a difference."

The pair said they worked with three or four Tastries employees and there could be no question that they were two women trying to order a cake for their wedding to each other.

Either they don't know her beliefs or they're going against them," Elena said.

Elena's mother, Kathleen Davis, wrote in an email to The Californian that the

cake was clearly for the marriage of two women.

My husband and I were at the reception hall when the cake arrived and the gal who delivered it set the cake up and even placed the topping with two brides atop the cake. The cake was beautiful, tasted fabulous and we were very pleased at the end of the day," Davis said. She said she saw the Tastries cake as a blessing

from God.

'It's truly ironic that according to my own Christian faith that I thought 'what a blessing that my Elena and Marissa will have such a beautiful cake,' she wrote. "Little did we know that Cathy Miller, for whatever reason, did not even realize what a blessing she was being to my daughter and her wife. If she had known, then she would have withheld

that blessing." The Californian's Facebook page has seen robust debate about Miller's stand as people weighed in on both sides of the controversy.

Miller's critics point out that state law does not allow business owners to refuse service to customers based on their race, religion, language or sexual orientation, among a number of other classes.

Supporters question why a business owner should be forced to abandon their reli-gious beliefs in order to be in

Elena and Marissa are just thankful they got their cake. But they are sad other weren't able to enjoy Tastries' exceptional cake and service.

Everyone deserves a nic cake for their wedding day, Elena Delgado said.

Cake for most means cake for all, even gays

hen you're planning a wedding, tasks that might otherwise seem mundane can take on a golden cast: You are, after all, preparing for what should be the happiest day of your life.

Ted G. Freitas and Adam Ramos must've had that feeling when they walked into a Bakers field bakery last week to select a wedding cake, They couldn't have known that the bakery's owner had such strong feelings about same-sex marriage that she would decline to prepare that giant traditional confection for them.

Tastries Bakery owner Cathy Miller says same-sex marriage conflicts with her religious beliefs, an objection we've heard before. In fact just such a case is headed to the U.S. Supreme Court: It's an appeal of a Colorado judge's ruling that finds that the same sort of reasoning Miller uses doesn't stand up to constitutional

Big Tobacco, and climate c

orests are the lungs of the Earth" is a ◀ longstanding and well-known analogy. Yet most of my good neighbors and friends in California's southern and central Sierra Nevada Mountains — an area ravaged by an unprecedented tree mortality crisis, with over 200 million trees dead - have nonetheless failed to carry the analogy through:

What the tobacco industry's primary products have been for the lungs of smokers, the fossil fuel industry's primary products have been for the lungs of our planet, its forests.

In other regions of California, the analogies between the corporate misbehaviors of Big Tobacco and Big Carbon have not gone unnoticed.

The counties of Marin and San Mateo and the City of Imperial Beach have recently taken to court what the Imperial Beach suit describes as "thirty seven major corporate members of the fossil fuel industry. citing patterns of willful concealment, obfuscation and distortion about that industry's

products and their dangers, dating back to 1965. These companies, writes Marin County District 3 Supervisor Kathrin Sears on her website, ripped a page from the tobacco lobby's playbook and launched a multimillion-dollar public relations and lobbying campaign to discredit scientific evidence about climate change, even while, in some instances, investing to protect their own assets from the impact of rising seas

These lawsuits have been brought by shoreline communities and are primarily concerned with issues of projected sea level rise. None of these suits come from forestland counties and communities. This is strange, given the fact the in the forestlands the disaster is not "projecte or "potential." It is already here, converting as sets - our trees - into liabilities

Those same trees, dead and dying en mass have become a "public nuisance" and must be removed in order to reduce fire and other hazards. Yet that removal simultaneously glu the timber market, rendering the trees of so little value that the cost of their disposal mo
