Declaration of Jessica Criollo

I, Jessica Criollo, declare as follows:

1. I have personal knowledge of the matters set forth herein. If called as a witness, I could testify competently as to the truth of the matters asserted herein, except as to those matters asserted upon information and belief, and, as to those matters, I believe them to be true.

2. I worked at Tastries Bakery in Bakersfield, California, between August 2015 and October 2015. Cathy Miller was my boss at Tastries. I was hired as a decorator, but Cathy later changed my position to focus more on baking than on decorating.

3. Tastries kept display cakes in the lobby for the purpose of helping customers decide what they'd like their cakes to look like. Cathy encouraged me to use my extra time to create display cakes by recreating cake designs in a stack of photos printed out from websites such as Pinterest. These were not photos of Tastries cakes. Instead, they were photos of cakes made by other bakers and bakeries. Cathy kept the stack of photos in a back room, which all the Tastries bakers and decorators could access.

4. When working on a pre-ordered "custom" cake, I would consult the completed order form. Some order forms included a drawing showing the requested design. Other order forms included an attached photo showing the requested design. Some of the attached photos were of Tastries display cakes. Many of the attached photos were of cakes made by other bakers or bakeries.

5. Many Tastries cakes, including pre-ordered "custom" cakes, can be used for any number of purposes, not just wedding celebrations.

6. None of the wedding cakes I worked on at Tastries were made from scratch. The chocolate and white buttercream frosting Tastries used for its wedding cakes was store-bought and used straight out of the container. Most of Tastries' cake flavors were made from store-bought box mixes, often without any additions, like pudding.

7. Twice, I helped deliver Tastries cakes to customers' wedding celebrations. No guests asked me questions about the cakes. I believe the delivery times were purposely scheduled earlier than the arrival of guests and the wedding party. I didn't leave Tastries business cards or any other



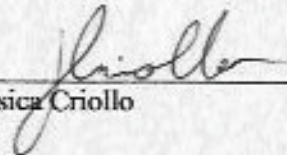
1 material that identified Tastries by name at the venues. I delivered each wedding cake in a car that
2 wasn't marked with Tastries' name or logo.

3 8. I run my own custom cake business, Tiers of Joy Cake Designs, which I co-founded
4 after leaving Tastries. Tiers of Joy provided a cake for the wedding celebration of Eileen and Mireya
5 Rodriguez-Del Rio after Tastries refused to sell them the cake they requested. When I met with
6 Eileen and Mireya to discuss the cake they wanted, I was surprised by how simple the design was.
7 The cake they wanted, and which we provided, was a simple, white, textured, three-tiered cake.

8 9. Making a cake like the one we provided Eileen and Mireya is quick and easy for an
9 experienced baker and decorator. Even a new baker or decorator in training at Tastries would be
10 expected to be able to make such a simple cake. Adding flowers made of frosting to the cake would
11 be just as simple. Frosting flowers, including rosettes, are very common cake decorations any cake
12 decorator should be able to quickly and easily make by squeezing frosting through a standard piping
13 bag tip.

14 I declare under penalty of perjury under the laws of the State of California that the foregoing
15 is true and correct.

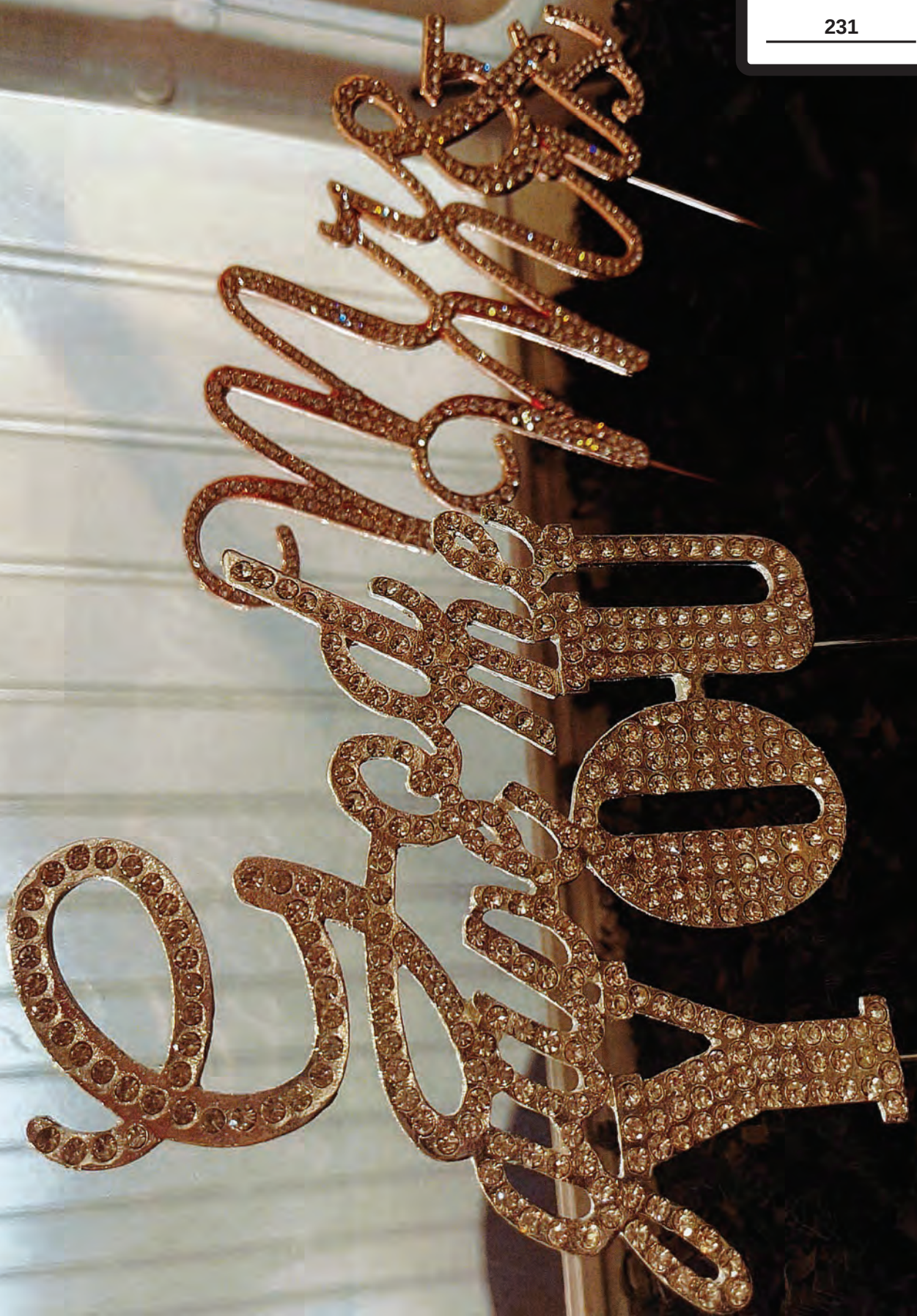

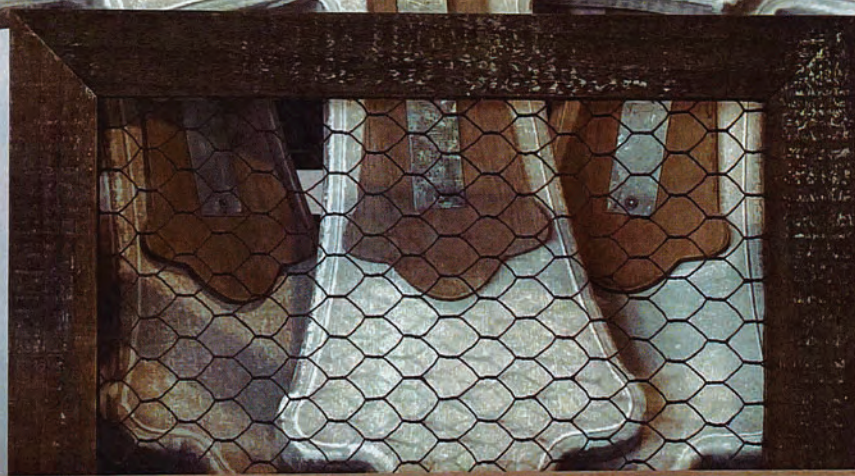
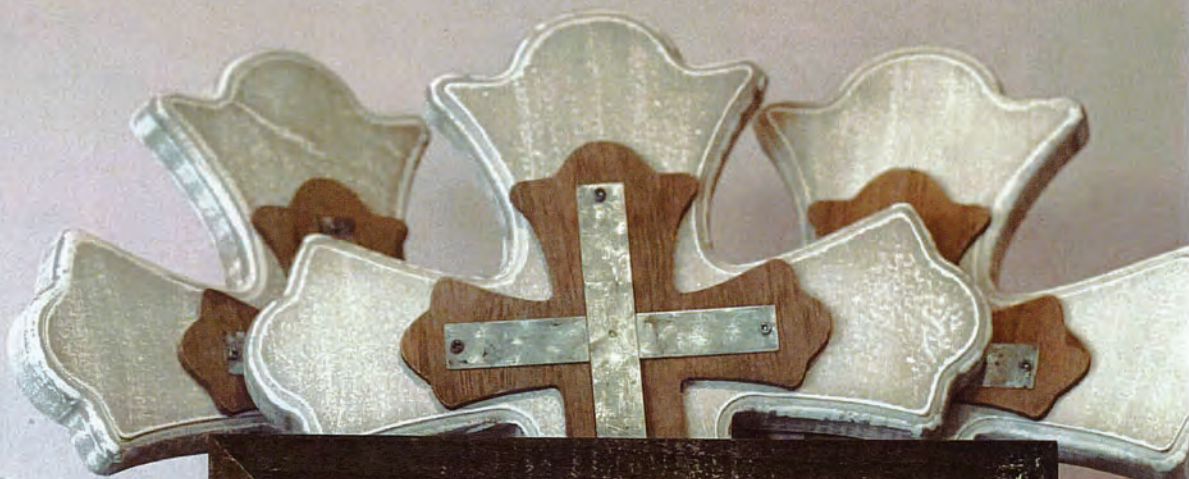

Declaration of Mary Johnson

I, Mary Johnson, declare as follows:

1. I have personal knowledge of the matters set forth herein. If called as a witness, I could testify competently as to the truth of the matters asserted herein, except as to those matters asserted upon information and belief, and, as to those matters, I believe them to be true.

2. I worked at Tastries Bakery in Bakersfield, California, between May 2013 and June 2017. Cathy Miller was my boss at Tastries. During my employment at Tastries, I became one of its lead decorators. Cathy put me in charge of overseeing some other decorators.

3. Tastries kept display cakes in the lobby for the purpose of helping customers decide what they'd like their cakes to look like. I created some of the display cakes. When asking me to create a display cake, Cathy would sometimes call me over to a computer to show me a photograph of a cake on Pinterest or another website. Other times, she would hand me a printout of a photo of a cake from Pinterest or another website. These were not photos of Tastries cakes. Instead, they were photos of cakes made by other bakers and bakeries. Cathy would ask me to recreate the cake in the photo to make a display cake. Sometimes she would tell me to recreate the cake with some modifications. But sometimes she would ask me to recreate the cake exactly as it appeared in the photo.

4. During my employment with Tastries, I met with some Tastries customers to take their cake orders and talk with them about what they wanted. I also trained some other decorators on how to get details from customers about their orders. The process for taking a cake order included asking the customers if they had any photos that showed what they wanted the cake to look like. Some customers brought photos of cakes made by other bakers or bakeries. Tastries bakers and decorators would copy the design of the cakes in these photos when creating the cakes these customers ordered.

5. When I took orders for custom cakes, including wedding cakes, I was able to gather all the information Tastries needed without becoming involved in the customer's event, often completing orders in around 20 minutes.



1 6. Many Tastries cakes look the same as cakes sold at grocery stores or other bakeries.
2 And many Tastries cakes, including pre-ordered or custom cakes, can be used for any number of
3 purposes, not just wedding celebrations.

4 7. Most or all of the wedding cakes I worked on at Tastries weren't made from scratch.
5 Tastries' chocolate and white buttercream frosting was store-bought and used straight out of the
6 container. Most of Tastries' cake flavors were made from store-bought box mixes, often without any
7 additions like pudding.

8 8. On several occasions I helped deliver Tastries wedding cakes to customers' wedding
9 celebrations. On most of these deliveries, I arrived well before the celebration started, and didn't see
10 any wedding guests or members of the wedding party. In my experience taking wedding cake orders,
11 the delivery was usually planned for a time when guests wouldn't be at the venue.

12 9. I have reviewed the picture of a simple, white, three-tiered cake attached as Exhibit 1.
13 The cake pictured in Exhibit 1 looks like a cake that was on display at Tastries when I worked there.
14 It is a very common and simple design ordered by many customers to celebrate birthdays,
15 quinceañeras, anniversaries, and other events, not just weddings.

16 10. Making a cake like the one pictured in Exhibit 1 would be quick and easy for an
17 experienced baker and decorator. Even a new baker or decorator in training at Tastries would be
18 expected to be able to make such a simple cake.

19 11. Tastries sometimes offered for sale a pre-made case cake that looked similar to the
20 cake pictured in Exhibit 1.

21 I declare under penalty of perjury under the laws of the State of California that the foregoing
22 is true and correct.

DECLARATION OF MIREYA RODRIGUEZ-DEL RIO

I, Mireya Rodriguez-Del Rio, declare as follows:

1. I am a complainant in this matter. I have personal knowledge of the matters set forth herein, and if called as a witness, I could testify competently as to the truth of the matters asserted herein, except as to those matters asserted upon information and belief, and, as to those matters, I believe them to be true.

2. I met Eileen Del Rio in the late 1990s at Bakersfield College, where I was an intern at the time. We became friends, and built a strong friendship over many years. In 2015 we started dating and soon became a couple. We were engaged in April 2016, and got married on December 7, 2016 in Bakersfield in front of our immediate families.

3. Although we were married, we wanted to have a larger ceremony and reception with our extended families and friends. So we set a date of October 7, 2017 for a wedding and reception with over 100 of our family members and close friends.

4. As part of our wedding and reception planning process we created a "to do" list. It included tasks such as find a venue, get a DJ, order a wedding cake, get a photographer, etc. As we completed each task we were relieved and happy: one less thing to do. The last two items on our list were order a wedding cake and find a photographer. The wedding cake was very important to Eileen and me. Throughout the process, we had no problems finding and contracting with any vendors except for the wedding cake with Tastries.

5. Eileen and I tasted cakes at two or three bakeries in Bakersfield, including Gimme Some Sugar and De Coeur Bake Shop, but were not happy with any of the cakes we tasted. So we were still looking for a wedding cake in August, a few months before our wedding.

6. Eileen told me she drove by a bakery, Tastries, and thought we should check it out. We decided to visit Tastries to inquire about its wedding cakes.

7. Eileen and I first visited Tastries on August 17, 2017, as part of our search for a wedding cake vendor. A Tastries employee named Rosemary assisted us and provided us with information about Tastries wedding cakes. Rosemary treated us kindly and was very warm. She answered our questions and showed us samples of cakes.

1 8. Eileen and I selected a simple cake design that was on display in the bakery, and
2 Rosemary provided us with a quote, which was about half the cost of other cakes we had looked at.
3 We did not want and did not request any written words or messages on the cake. Rosemary also
4 suggested that we come back for a free cake-tasting on Saturday, August 26, and we agreed.

5 9. Eileen and I were very pleased with this initial experience at Tastries. Having had no
6 luck at other bakeries, we planned to place an order for a Tastries wedding cake after the cake-tasting.

7 10. On the morning of August 26, 2017, Eileen missed a call from Rosemary with
8 Tastries. I called Tastries back and talked to Rosemary, and she asked me if we were still coming in
9 because she had seen question marks next to our names. I told her we were on our way, and she said
10 see you soon.

11 11. We arrived at our scheduled appointment on August 26, 2017, with Eileen's mother,
12 and met my man of honor and his partner. The five of us were excited to taste Tastries cakes, and
13 order our wedding cake!

14 12. Rosemary greeted us and started assisting us. But she soon apologized and told me
15 that her boss was going to take over assisting us with our cake order. The "boss" came over to us,
16 and said she was Cathy Miller and was taking over. We were confused.

17 13. Ms. Miller led us to the back of the bakery away from the other customers. She asked
18 us what we were looking for. Eileen told her that we already provided details about the wedding cake
19 we were looking for to Rosemary. Ms. Miller wrote something down on the bakery's quote sheet,
20 told me and Eileen that the cake will cost \$260, and that she was going to send the order over to
21 Stephanie because she does not condone same-sex marriage.

22 14. Confused, Eileen asked Ms. Miller who she was giving our order to. I told Ms. Miller
23 I was under the impression Tastries would be making our wedding cake. Ms. Miller responded that
24 she does not condone same-sex marriage, and told us that she always sends such orders to Stephanie
25 at Gimme Some Sugar. I was shocked, offended and hurt. Eileen told Ms. Miller why would we go
26 through you to get a cake from Stephanie when we could just go to her and deal with her personally.
27 Ms. Miller said we could still taste cakes. We said no, and then walked out of the bakery.
28

15. We drove by Gimme Some Sugar, and Eileen realized that she had already tasted cakes there. She had already decided against ordering our wedding cake from there.

16. Next we went for coffee with Eileen's mom and my man of honor and his partner just to talk about what had just happened at Tastries. We were all in shock and could not believe what she had said and done. We were done for the day after that but needed to run an errand. After arriving at our destination, Eileen and I sat in the car for around 30 minutes as we processed what had just happened to us. I broke down. I cried for almost a half hour. I also got a headache and a bad nose bleed. I do not get nose bleeds, so I was quite surprised, and knew it was a result of the discrimination I had just endured. I have not had a nose bleed since.

17. Ms. Miller's refusal to provide us a wedding cake devastated us both. Eileen was a rock for me for around a week-and-a-half. Then her rheumatoid arthritis flared up and she could barely get out of bed. I was hurt, upset, angry and frustrated at Ms. Miller's discrimination.

18. We had planned to order our wedding cake from Tastries. Now, here we were about a month-and-a-half before our wedding and we had no cake and no leads. We considered just buying a pre-made non-wedding cake from Food for Less or Costco. Up until that experience with Ms. Miller, wedding planning was going well and we had no trouble with any vendors. But Ms. Miller's discrimination was so heartbreaking to Eileen and me that it took all the joy out of the process.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.
